EXECUTIVE ENGINEER

Instructions to Tenderers for filling the Tender

1. The tenderer should carefully read and study the specifications and should submit the tender accordingly. Figures should be given both in numbers and words. All cuttings and over writings should be duly signed and attested.
 2. All General and Special conditions given in the specification alongwith General conditions of Form 'A' of Madhyanchal Vidyut Vitran Nitam Ltd/ U.P.P.C.L. shall be binding on the tenderer.
 3. The tenders shall be accepted only on the proforma being supplied with this specification. Any tender in other than supplied proforma may be rejected.
 4. Tender shall be submitted in two parts, each parts in separately sealed envelope and both the envelopes placed in one cover duly superscribed with "Tender against specification no. **07/ESD/LESA/2016-17**
- 4.1 **TENDER BID PART-I** : shall contain earnest money amounting to Rs.2000.00 (Two thousands) only in the shape of FDR/CDR/ Bank Draft of Nationalised Bank in favour of Executive Engineer, Electricity Stores Division, Lesa, Lucknow and photocopy of Experience, Service Tax Registration for works & Income Tax Certificate etc. shall be sent in sealed cover superscribed "Tender Bid Part-1" (Earnest Money) against tender specification No. **07/ESD/LESA/2016-17**. Earnest Money in any other form shall not be accepted.
- 4.1.1 The tenders without or with insufficient earnest money shall be rejected similarity, their second part shall not be opened. The request of tenderer for adjusting earnest money from their pending bills, security or other deposits with this division or with other units of MVVNL will not be acceptable and if

they give any such condition, their tender will be treated as without earnest money. No relaxation in deposition of earnest money may be allowed. Suppliers/contractors registered on D/G/S/ & D. Director of Industry, U.P. and others will also have to deposit the requisite earnest money. Any such registration will not entitle the tenderer for exemption from deposit of earnest money.

4.1.2 The earnest money will be refunded except in case of successful tenderer in which case their earnest money will be converted/adjusted against security deposit, if desired by the successful tenderer.

4.1.3 Declaration form dully filled on Non/judicial stamp paper worth Rs. 10.00 only duly signed by the contractor alongwith revenue stamp worth Rs. 1.00 only affixed on it which should be signed half on revenue stamp and half on non-judicial stamp paper as per matter given in declaration proform supplied with specification.

4.2 **TENDER BID PART-II** : will contain the following documents duly signed by the tenderer :

4.2.1 Item-wise rates, terms & conditions etc. should be filled in the proforma of rate schedule supplied alongwith specification.

5. Tenders will be received upto 14:00 hrs. on 03.03.2017 and will be opened at 15:00 hrs. on the same day by the undersigned or by authorized officers in the presence of such tenderer of their authorized representative who may choose to be present at the time of opening of the enders. In case the day of opening happens to be a holiday, the tender shall be opened on the next working day at the fixed timings without any subsequent notice.

6. Part-I of the tender containing earnest money etc. will be opened 1st and in case the tender is without earnest money or insufficient amount of earnest money, Part-II containing rates etc. will not be opened.
7. Incomplete tenders or the tenders wrongly filled in and not in accordance with the instruction, are liable to be rejected.
8. Tenders of only those parties shall be accepted who have purchased the tender papers from the office of undersigned / S.E., ESC, Lucknow or downloaded from our site www.mvvnI.com
9. Undersigned reserves the right to reject any or all tenders or to split the same between two or more parties without assigning any reason thereof.

07/ESD/LESA/2016-17 FOR CUTTING & HANDLING OF STEEL SECTIONS AT
ELECTRICITY STORE CENTER, LUCKNOW

1. Cutting shall have to be done with Gas cutter.
2. The work shall be carried out at Electy. Store Center, lucknow during working hours in working days. Cutting works will be done as per RESSPO Norms.
3. The quantity of indivisual itirms can vary to any extent as per actual requirement (Total quantity can vary upto $\pm 10\%$)
4. The cutting is to be carried out from time to time as per actual requirement and availability of steel.
5. The Contractor shall have to make arrangement for shifting of material from stacking place to working site and from working site to store shed withproper stacking.
6. The Contractor shall have ot aggange required T&P, Gas cutter, Gas and labour etc. for which no additional charges will be paid extra.
7. The Contractor will be responsible for accident. If any and compensation thereof occurs during execution of work
8. The Contractor will abide by the prevailing labour law.
9. The work shall be carried out during one year from the date of awarding the contract.
10. Other condition as performa A shall be applicable.
11. The work shall be done under supervision of concerned Assistant Engineer/ Assistant Store Keeper. The contractor will be responsible of timely completion of work within the stipulated time as provided in order to be placed by the Executive Engineer or the Assistant Engineer concern of the division. If the contractor fails to execute the work within stipulated time, the order placing authority reserves the right to get the work executed by other agency. The excess expenditure incurred in the connection plus 15% supervision charges including penalty levied if any will be payable by the contractor.
12. If the item is cut as per wrong length, resulting the wastage of the steel, the cost shall be deducted as per rules and wastage of the same shall be contractor's property.

- 13. Security :** The successful tenderer/contractor will be required to deposit security for faithful performance. Earnest money of Rs 2000-00 shall be converted into security deposit. Beside above 10 % security shall also be deducted from the running bills.
- 14. Penalty :** penalty@0.5 % per week for delay in execution of the work shall be payable by the contractor on the total value of the work not done. The maximum penalty leviable will not, however exceed 10 % of the value of the order not executed as specified in the work memo.
- 15.** Fabrication of steel sections will be done by cutting and without hole.
- 16. Period of Agreement :** The validity of agreement executed with the successful tenderer will be for a period of one year or as decided by the Engineer of contract from the date of agreement subject to a maximum financial limit which ever occur earlier.
- 17. Tax Chargers :** MVVNL is not exempted from the payment of any tax charges. The rates should include all such charges for the transit place. Octroi and toll tax charges at terminal destinations only are payable by the department. The contractor will have to pay such charges at the initial stage and would claim re-imbursement for terminal destination claim charges only within a week. IncomeTax at prevailing rates shall be deducted from contractors bill before making payments as per Income Tax Rules.
- 18.** Service Tax a per rule if legally applicable.
